**No. F. 14(6) Mines/Gr.II/2015** .-In exercise of powers conferred by sub-section (1) of section 9B, sub-section (4) of section 15 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act No. 67 of 1957) and rule 5 of District Mineral Foundation Trust Rules, 2016, the State Government hereby establish trusts in all the districts of the State to be called as the District Mineral Foundation Trust (DMFT) with a Governing Council and Managing Committee.
